Sub:- Grant of Recognition to the school from Class-Ist to XII th (without aid) w.e.f. the Academic session 2001-2002.

Sir,

With reference to your application on the subject cited above, I am directed to convey the approval of appropriate authority for grant of Recognition to your school from Class-Ist to XII th (without aid) w.e.f. the academic session 2001-2002 subject to the fulfilments of the following terms and conditions:-

1. That the school shall abide by the provisions of Delhi School Education Act, 1973 and Rules framed there under as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed.
3. That the school shall meet the additional liability of Secondary and Senior Secondary Classes.
4. That the school shall purchase adequate Science Lab. equipments and apparatus as per the norms of C.B.S.E./Education Department for Secondary/Senior Secondary Classes.
5. That a proper library shall be established and facilities for reading rooms shall also be made available for students as well as teachers. Books as per the ratio of 10 books per students shall be purchased and made available to the students.
6. That adequate sports material shall be purchased and made available to the students.
7. That the school shall strictly abide by the provisions of Section 10(1) of the Delhi School Education Act/Rules, 1973.
8. That the school shall not run any un-recognised classes or any non-educational activities within the school premises and all the recognised classes shall be run at any place at the above address only. Nursery classes be removed from the premises of the school immediately, if any.
9. That the school shall dispense with the services of un-qualified and over-aged staff, if any immediately.
10. Fresh Health Certificate from M.C.D. be obtained and produced to Education Officer for verification.

11. The Management of the school will obtain land from D.D.A. if already not obtained, in the name of the Society through Directorate of Education, Delhi and shall construct a school building thereon for the school as per specifications of the department within a period of 2 years. That adequate and sufficient accomodation of 10 Sq.Ft. per students shall be provided for class-room. The normal size of the class-room will 15' x 20'.
12. That proper facilities for drinking water, toilets and first-aid be provided. Seperate toilets for boys, girls and separte te toilets for ladies and gents staff be also provided.
13. That the Managing Committee of the school shall not increase enhance fee during the ensuring academic session without prior approval of the Director of Education which is a mandatory requirement under sub-section(3) of Section-17 of Delhi School Education Act & Rules, 1973.
14. That all the facilities prescribed under Rules 50 & 51 of the D.S.E.R-1973 shall be made available to the students.
15. That XIth class should not be added without the prior approva of the Director of Education.
16. That the mangement of the school shall greate a Reserve Fund equal to minimum three months salary of the staff in the joint name of the Director of Education and Manager of the School.
17. That the school shall comply with the norms of the C.B.S.E. for affiliation fee/examination purposes.
18. That report about the fulfilment of the above conditions shall be sent to the Education Officer within six-months.
19. Fee and other charges are not being realized in terms of the heads and the amounts as directed by the Director of Education.
20. Building Completion Certificate is not submitted.
21. Appointment letter is very defective.
22. The Music Teacher is not only under-qualified but placed in the pay scale of Asstt.Tr.
23. The Managing Committee has not been constitut3d as per the approved scheme of mangement.
24. The recognition granted for Class-Ist to XIIth for Arts and commerce streams at the + 2 stage w.e.f the session 2001-02 as an unaided school under rule 52 of the DSE^R, 1973 with the condition that the deficiencies listed at Sl.No.19 to 23 mus be removed within three months of the date of recognition failing which the recognition granted to the school shall automatically lapse on the expiry of the stipulated period.

The school may be warned to be more careful in compliance of the provisions of the Act and the Rules in future.


